This research aims to optimize the use of the website as a publication medium for the Tontouan Village Government's work program. The method used in this research is descriptive qualitative research. By using data collection techniques starting with observation, interviews, and documentation. Based on the results of this study, it shows that there is a significant increase in the utilization or use of websites carried out by the government in managing publication media related to the work program of the Tontouan Village government to manage and publish work programs through the website, making it easier for people to access information without the need to come to the village office. In addition, the results of this study show that the optimization of the use of the website as a publication medium for Tontouan Village information is as follows: Optimizing the use of the website as a publication medium for Tontouan Village information, researchers use two principles, namely optimization based on the characteristics and objectives of the website as an online publication medium. The characteristics include the speed and actuality of information, updating information, and interactivity, while the purpose of the website as a publication media includes information dissemination, research purposes, and improving services to the community as well as updates in the publication of Tontouan Village work programs. INTRODUCTION

"These changes were made to provide comfort and convenience to the community to use the website as an online publication media. "Based on the explanation above, the researcher is interested in conducting research on optimizing the use of the website as a publication medium for tontoan village information. "Finally, through this research, it can be known whether the Tontouan Village website has undergone changes that can really be an effective and efficient publication media for all elements of society.

To realize public service well and optimally, the Tontouan Village office has electronic services in the form of the Tountouan Village Website as a form of public service information that makes it easier and faster to provide public services and to make it easier to manage the needs of citizens.

Print media means media published by printing or using paper. In addition to the publication media above, the website is a very appropriate publication alternative for the publication of village information so that the public can easily access information related to village work programs. Publications have an important role in facilitating the flow of information, advancing knowledge, and building meaningful interactions between



individuals in society. In the digital age, blogs, websites and social media platforms allow individuals to publish their thoughts, stories and views to a wider audience.(Mahfuzhah and Anshari 2018)

From print media such as newspapers and magazines to electronic media such as radio, television, and the internet, all provide platforms to disseminate information, promote ideas, and spark discussions. They also play a role in informing the public about important issues, such as elections, environmental health issues, school bullying, and so on. By providing wider access to the latest news and information, they help shape public opinion, strengthen democratic participation, and mobilize social action.

As such, it acts as a bridge that connects individuals and groups in society, gives voice to the unheard, and promotes positive change.

C. Government Work Program

The Village Government Work Plan (RKP) is a planning document that contains the main points of village development policy and guides towards the goal of achieving the village's vision and mission. The purpose and objectives of the Village RKP are the realization of annual village planning in an effort to realize the Village Medium-Term Development Plan, the achievement of maximum, efficient and effective utilization of village potential in village development towards an independent and prosperous village.

The Village Government Work Plan (RKP) is an elaboration of the RPJMDesa and other planning documents, as planning for other fields, sub-fields and activities that are prepared by considering participatory input and inspiration, discussed and agreed upon in the Village musrenbang forum. Based on the provisions of Article 79 of Law Number 6 of 2014 concerning Villages, the Village Government is obliged to prepare village development planning in accordance with its authority with reference to district development planning. The Village Government Work Plan, hereinafter referred to as the Village RKP, is an elaboration of the Village RPJM for a period of 1 (one) year, which contains plans for organizing village administration, implementing development, fostering community development, and empowering village communities. The Village RKP also includes information on the Village's economic framework, the results of evaluating the implementation of the previous year's development, supra-Village policy priorities, rural area development and matters relating to disaster management, emergencies and policies from urgency as well as the Government, Provincial Government or Regency Government.

In addition to the above objectives, the objectives to be achieved in the preparation of the Village Government Work Plan are as follows: Framework of reference for the Village Head and Village Apparatus in preparing synergistic annual programs and activities in accordance with their main tasks and functions to realize the achievement of the vision and mission set out in the Village RPJM. As an instrument for assessing the performance of village officials, in measuring the effectiveness of the implementation of their duties. as well as an instrument of accountability and transparency of village government management by the community and elements of government observers who



have an interest in monitoring the performance of the village government.

METHODOLOGY

This research uses a qualitative descriptive method with an observation, interview and documentation approach and focuses on optimizing the use of the website in updating the Tontouan Village work program. According to Sutrisno Hadi in (Sugiyono, 2018: 145) argues that, "Observation is a complex process, a process composed of psychological various biological and processes. Two of the most important are the processes of observation and memory." (Fadli 2021)

According to Moleong (2016: 186) states that "An interview is a conversation with a specific purpose. The conversation is carried out by two parties, namely the interviewer (interviewer) who asks questions and the interviewee (interviewee) provides who answers to those questions ". Sugiyono (2018: 137) interviews are used as a data collection technique if you want to conduct a preliminary study to find problems that must be researched and also if the researcher wants to know things from respondents that are more in-depth and the number of respondents is small. The interview technique that the author applies in this research is a semi-structured interview because researchers can explore the data more broadly and get more data from the sources. The interview was conducted with the operator staff of Tontouan Village as the provider of information about the data needed, namely the Informant. (Mundir 2013)

According to Moleong in the journal (Sumiati, 2015: 61) describes "Research subjects as informants, which means people who are used to provide information about the situation and conditions of the research site." Based on the results of the research that the information conveyed on the tontouan village website is the activities that exist and are carried out in the village, such as training and health counseling for health workers, cadres, as well as direct cash assistance distribution activities and other activities in tontouan village. carried activities out are uploaded quickly and actually, so that people can easily access information on village activities quickly. (Setiyaji, Anggitya, and Musta'an 2017)

2. Updating Information Information updating is an update information that is delivered continuously. Α information website as an publication media is required to update information or provide new information on website posts. The results of interviews

Based on what has been explained above. the information contained on the Tontouan Village website is the latest information, this can also be seen from the latest posts displayed on the latest posts on the Tontouan Village website. So it can be concluded that the Tontouan Village website as a publication media always displays the latest and most recent information.

3. Interactivity

Website as a publication media must have interactivity between website users and administrators so that the website can develop even better. As a two-way



communication media, interactivity provides an opportunity for communicants to convey complaints, suggestions, criticisms directly through the columns provided on the website. Based on the interview results, the Tontouan Village website is equipped with a criticism and suggestion menu that can be used by website visitors to provide input so that the Tontouan Village website can develop for the better. In accordance with the results of interviews with website manager informants that there is an opportunity for website visitors provide criticism to and suggestions through the criticism and suggestion menu that has been prepared on the tontouan village website.In addition, we also display the village email so that website visitors can contact the village to find more complete information about the village.So it can be concluded that the tontouan village website as a publication media has interactivity between website users and administrators, this can be seen from the existence of a Criticism and Suggestion menu on thewebsite.

- B. Optimization Based on the Purpose of the Website as a Publication Media
 - Dissemination of Information The purpose of the website as the first publication media is the dissemination of information. The intended information

The following is explanation an from the informant:

"Our website for disseminating information about Tontouan Village has been



with equipped menus and features that make it easy for visitors to find out information about the village clearly. On the website there is an about menu, a data menu and other menus contain information that according to the menu name given. Our website also has a social media menu at the top so that it makes it easier for the to communicate community with the government or provide suggestions and criticisms related to village activities or village programs. In addition, our website can be easily accessed anytime, anywhere".

Based on the explanation above, it can be concluded that the tontouan village website as a publication media has been supported by menus and features that are useful in disseminating information.

2. Research Objectives

The second purpose of the website as a publication medium is research purposes. What is meant by research purposes is that websites can be used to collect data or information that can be used to conduct research (Yudhaningsih 2011). Improving services in question is that the existence of an institutional website can improve services to the community, in the form of providing convenience to the community such as easy access to information, ease of searching village data and village profiles. Based on the results of the interviews that have been conducted, the tontouan village website is used by the tontouan village government to improve services. As explained by the



informant as follows:

"Our website is also used to improve services to the community. As in the information menu, on the menu there are service features, announcements, agendas, data banks, and legal products ".

Based the on explanation above, it can be concluded that the Tontouan Village website as a publication media can improve services, especially in services to the community contained in the interaction menu and information menu. Besides that, services can also be seen on the information menu which contains news about the Village Tontouan work program.

CONCLUSION

Based on the results of the study, it shows that optimizing the use of the website as a publication media for Tontouan Village information can be seen in two factors; First, optimization based on the

characteristics of the website as a publication media, including: a) the Tontouan Village website has speed and actuality of information; b) the Tontouan Village website always provides the latest information; c) the Tontuan Village website has interactivity between website visitors administrators. Second. and optimization based on the purpose of the website as a publication media, including: a) the Tontouan Village website has been supported by menus
